Your Directors present their interim report together with the financial statements, on the consolidated entity (referred to hereafter as "the consolidated entity" or "HUB24 consolidated entity") consisting of HUB24 Limited (referred to hereafter as "the company") and the entities it controlled for the half-year ended 31 December 2015.

DIRECTORS

The Directors were in office from the beginning of the half year and until the date of this report, unless otherwise stated.

CONSOLIDATED ENTITY OVERVIEW

HUB24 Limited operates the HUB24 investment and superannuation platform and provides financial advice to clients through financial advisers authorised by Paragem Pty Ltd.

The HUB24 investment and superannuation platform is leading the wealth management industry by offering one of the most functional managed portfolio and Separately Managed Account ("SMA") platforms on the market. It is recognised as a leading independent portfolio administration service that provides financial advisers with the capability to offer their clients access to a wide range of investments including efficient and cost effective trading, insurance and comprehensive reporting for all types of investors – individuals, companies, trusts or self-managed super funds. HUB24 was established by a team with a strong track record of delivering market-leading solutions in the financial services industry. Since launching the superannuation service in July 2012, HUB24 has grown Funds Under Administration ("FUA") from \$0.1 billion to in excess of \$2.3billion and over 556 advisers actively using the platform.

Paragem Pty Ltd is a wholly owned subsidiary and boutique dealer group offering licensee services. It comprises a network of 22 independently minded financial advice businesses, having recruited two additional practices during the half year, which deliver cost effective, high quality advice. It provides compliance, systems and support to the practices enabling advisers to provide clients with financial advice over a range of products.

PRINCIPAL ACTIVITIES

The principal activities during the half-year of the company were the provision of investment and superannuation portfolio administration services and the provision of licensee services.

REVIEW OF OPERATIONS

The company has continued to see improvements in its financial results for the half year ended 31 December 2015 due to a disciplined focus on investment initiatives in platform development and the transition of FUA to the platform.

The company recorded two quarters of record gross inflows during the half year ended 31 December 2015 with net inflows of \$668 million and FUA at 31 December 2015 of \$2.368 billion generating recurring platform revenue of \$6.963 million.



FUA BALANCE



The company announced new white label agreements with two dealer groups during the half year ended 31 December 2015 which are expected to contribute to the company's continued growth in its core platform service offerings.

Platform developments during the half year ended 31 December 2015 were launched for international managed portfolios enabling investors to directly own international listed companies via professionally managed portfolios from more than 15 global markets.

Continuing investment in platform development has seen HUB24 recognised in the Investment Trends 2015 Platform Benchmarking Report¹ whereby HUB24:

- Continues to be ranked in the top three platforms in the industry in terms of overall platform functionality with outstanding scores achieved in decision support, reporting and access
- Won the award for Best Navigation and User Interface
- Won the award for Best Tablet/Smartphone Access
- Of the top three, ranked ahead of the other two platforms in terms of managed accounts functionality which is a key value proposition for the company.

620,000 share options were issued to staff and executives on

14 October 2015 under the HUB24 Share Option plan. 150,000 options were issued to the Managing Director on 7 December 2015 after being approved by shareholders at the Annual General Meeting of the company held 25 November 2015.

On 8 October 2015 the company announced it had received an indicative, non-binding and conditional proposal from IOOF Holdings Ltd to acquire 100% of the company's shares for cash consideration of \$2.75 per share. The Board rejected the proposal as it believed that it did not reflect the underlying value of the company and the proposal was subsequently withdrawn.

Anthony McDonald was appointed to the position of Non-Executive Director effective 1 September 2015.

REVIEW OF FINANCIAL RESULTS

The consolidated entity recorded revenue from ordinary activities of \$20.443 million for the half year ended 31 December 2015 (revenue from ordinary activities of \$11.973 million for the half year ended 31 December 2014) an increase of 71%.

A loss after income tax of \$1.820 million was recorded for the half year ended 31 December 2015 (loss of \$2.847 million for the half year ended 31 December 2014) an improvement of 36%.

Included in this result were the following significant items:

- Platform revenue increased by 114% to \$6.963 million for the half year ended 31 December 2015 (\$3.247 million for the half year ended 31 December 2014) and platform direct costs increased by 49% to \$3.266 million (\$2.198 million for the half year ended 31 December 2014);
- Licensee revenue increased by 65% to \$13.074 million for the half year ended 31 December 2015 (\$7.922 million for the four months ended 31 December 2014).

The following representation of the financial performance of the consolidated entity is based upon internal reports (unaudited) that are reviewed and used by management and the board in assessing performance and determining the allocation of resources. Management and the board review Earnings Before Interest, Tax, Depreciation and Amortisation ("EBITDA") from continuing operations before material non-recurring and non-cash items. Prior year comparative numbers include the Licensee segment for the period 1 September 2014 to 31 December 2014 and have been restated due to a change in accounting policy in relation to the recognition of research and development grants as outlined in Note 7 to the Financial Statements.

Revenue due to ordinary activities from continuing operations comprises recurring revenue, non-recurring revenue and interest revenue.

REVENUE

DIRFCTORS

Strong FUA inflows into the HUB24 platform have resulted in recurring platform revenue of \$6.963 million for the half year ended 31 December 2015, an increase of 114% over the prior corresponding period. The Licensee has contributed \$13.074 million in revenue for the half year ended 31 December 2015 (\$7.922 million for the four months ended 31 December 2014). Revenue is sensitive to movements in equity markets given a significant proportion of client funds are in either directly held or managed assets with equity market exposure.

GROSS PROFIT

Strong FUA inflows, increased trading activity and recruitment of adviser practices together with continuing scale benefits have driven a strong gross profit result of \$4.790 million for the half year ended 31 December 2015 [\$1.714 million for the half year ended 31 December 2014], an increase of 179%.

Direct platform costs include custody, trustee, superannuation administration and headcount resources to service current client accounts while direct Licensee costs include payments to advisers for advice fees and suppliers of compliance, software and training services.

OPERATING EBITDA

Operating EBITDA is a representation of the EBITDA result the company would record if it were to service only the current amount of FUA and associated client accounts. It assumes no expenses are invested to bring additional FUA onto the platform nor to develop new platform features. While HUB24 will continue to invest in the expansion of FUA and further development, Operating EBITDA is an important internal measure and milestone for the platform.

The company has experienced record growth in net inflows and FUA during the half year ended 31 December 2015 and it has taken the opportunity to strengthen its corporate fixed cost base in order to support the continued growth of the business over the next few years. As a result, operating expenses increased by 52% during the period, an increase of 33% when normalised for the full six months of operating results for the Licensee segment.

This increase is made up of additional employment costs including personnel recruited for corporate services and board costs including the appointment of an additional director; a step change in investing in the platform's IT infrastructure and one-off implementation costs associated with the introduction of new AML / CTF legislation introduced 1 January 2016; and establishment of an office presence in Brisbane to support growth in that market.

The Operating EBITDA result of \$1.204 million for the half year ended 31 December 2015 has improved by 285% over the previous corresponding period (loss of \$0.652 million).

GROWTH RESOURCES EXPENSED

Growth resources are predominantly headcount resources dedicated to future platform development, business strategy (inclusive of M&A activity) and to accelerate additional FUA onto the platform. They include resources across sales, development and transition functions.

Growth resources of \$0.526 million were capitalised during the half year ended 31 December 2015 relating to specific projects for the development of functionality for international equities and non-custodial assets (\$0.447 million for the half year ended 31 December 2014).

OTHER SIGNIFICANT ITEMS

Share based payment expenses of \$0.678 million for the half year ended 31 December 2015 were inclusive of \$0.279 million relating to the acquisition of Paragem Pty Ltd and \$0.399 million due to the issue of options to executives, the Chairman and staff during the past three years ended 31 December 2015. The expense increase compared with the prior corresponding period is due to the issue of options during the half year ended 31 December 2015 and an adjustment to the expected probability of options vesting.

Depreciation and amortisation of \$0.363 million for the half year ended 31 December 2015 is inclusive of increased amortisation of the platform intangible asset arising from the commercialisation of development projects in 2015 and amortisation of the dealer network intangible asset.

Non-recurring corporate costs of \$0.261 million for the half year ended 31 December 2015 include \$0.130 million of valuation and corporate advisory expenses associated with the indicative, conditional and non-binding proposal received by the company on 8 October 2015. Other costs relate to one-off indirect tax advice, legal expenses relating to corporate matters and the evaluation of potential business opportunities.



CASH FLOWS

During the half year the company transitioned to be operating cash flow positive on a monthly basis as demonstrated by positive Cashflows from Operating Activities for the months of November and December 2015².

This trend is expected to continue into the second half of the financial year in line with ongoing growth in FUA.

The Group held \$10.522 million in cash and cash equivalents as at 31 December 2015 (\$12.109 million as at 30 June 2015).

Net cash outflows from operating activities for the half year ended 31 December 2015 were (\$0.144 million) after inclusion of one-off receipts from the ATO relating to reduced input tax credits of \$1.212 million.

OPERATING SEGMENTS

The principal products and services for each of the operating segments are as follows:

Development and provision of investment and superannuation platform services to financial advisers, stockbrokers, accountants and their clients.
Provision of financial advice to clients through financial advisers authorised by Paragem Pty Ltd. The Licensee provides compliance, systems and support to adviser practices, enabling advisers to provide clients with financial advice over a range of products.
Provision of corporate services to the operating segments including allocation of costs of the Managing Director, finance and compliance, and strategic support.

PLATFORM REVENUE – 1HFY16


The platform segment recorded significant improvements in revenue, gross profit, operating EBITDA and EBITDA for the half year ended 31 December 2015 due to increases in FUA with expanding margins.

While recurring revenue increased by 114%, direct costs increased by only 49%, demonstrating the continued benefits of scale.

Platform operating expenses increased by 47% in response to record growth in net inflows and FUA ahead of internal targets. For further explanation of the variance in operating expenses please refer to page 8 of this director's report.

The results for the platform segment as a percentage of average FUA for the half year ended 31 December 2015 demonstrate continuing margin improvements at each profit line.

PLATFORM – GROSS PROFIT, OPERATING EBITDA & EBITDA TRENDS



This chart demonstrates the dual impact of increasing volumes and margin expansion on the dollar value of gross profit, operating EBITDA and EBITDA when comparing the half year periods 1HFY14 to 1HFY16.

LICENSEE SEGMENT

Paragem Pty Ltd, the Licensee, provides licensing for financial planning practices with above industry average funds under advice per adviser. The practices seek the freedom to exert their independence through broad choice of investment and insurance options and they embrace the changing shape of the advice industry. The Licensee provides assistance to practices wishing to implement managed portfolios for their clients, assisting them to deliver contemporary investment solutions and improving the efficiency of their business such that operational scale and professional fees are the primary drivers of profitability.

While the Licensee's advisers continue to be free to choose whichever platform best suits their clients' needs, the take-up of HUB24 has been strong due to the ability of the platform to cater for both traditional managed fund investments as well as the emerging breed of managed portfolios and SMAs typically expected in the high net worth investor and SMSF sectors.

REVENUE GROWTH

The Licensee business has grown revenues since transitioning to HUB24 on 1 September 2014. Two new practices joined the Licensee during the half year ended 31 December 2015, contributing to a revenue increase of 12% over the half year ended 31 December 2014.

The acquisition of Paragem Pty Ltd is consistent with HUB24's core proposition of providing high value services to licensees and advisers. This entry into the advice space is resulting in further enhancements of HUB24's rapid growth, diversification of the company's revenue streams and continued improvements to platform functionality, which is highly valued by the broader, independently minded financial advice market.

1. APPROVAL OF FINANCIAL STATEMENTS

The financial statements of HUB24 Limited for the half-year ended 31 December 2015 were authorised for issue in accordance with a resolution of the Board of Directors on 25 February 2016.

2. BASIS OF PREPARATION AND ACCOUNTING POLICIES

Basis of preparation

This general purpose interim financial report for the half-year ended 31 December 2015 has been prepared in accordance with AASB 134 *Interim Financial Reporting* and the *Corporations Act 2001*, as appropriate for for-profit oriented entities. Compliance with AASB 134 ensures compliance with International Financial Reporting Standard IAS 34 'Interim Financial Reporting'.

These half-year financial statements do not include all the notes of the type normally included in the annual financial report and therefore cannot be expected to provide a full understanding of the financial performance, financial position and financing and investing activities of the consolidated entity. Accordingly, it is recommended that the half-year financial report be read in conjunction with the annual report for the year ended 30 June 2015 and considered together with any public announcements made by HUB24 Limited ('the Company') during the half-year ended 31 December 2015 in accordance with the continuous disclosure obligations of the ASX listing rules and the Corporations Act 2001.

Certain prior year numbers have been reclassified to conform to current year presentation.

Statement of compliance

The financial report complies with Australian Accounting Standards applicable to interim reporting as issued by the Australian Accounting Standards Board and International Financial Reporting Standards (IFRS) applicable to interim reporting as issued by the International Accounting Standards Board.

New, revised or amending Accounting Standards and Interpretations adopted

There are no material changes to accounting standards since the Annual Report for the year ended 30 June 2015 that impact the financial performance or position of the consolidated entity.

Significant accounting policies

The half-year consolidated financial statements have been prepared using the same accounting policies as used in the annual financial statements for the year ended 30 June 2015.

Basis of consolidation

The half-year consolidated financial statements comprise the financial statements of the consolidated entity as at 31 December 2015.

Subsidiaries are consolidated from the date on which control is transferred to the consolidated entity.

Going concern

The financial report has been prepared on a going concern basis.

The consolidated entity has raised capital in the prior years from multiple sources for acquisition, regulatory capital requirements, investment platform development and working capital purposes. Accordingly, the directors of the company are confident of sourcing additional capital as and when required.

3. REVENUE AND EXPENSES FROM CONTINUING OPERATIONS

The current period administrative expenses include \$261,584 in transaction expenses and \$278,833 contingent consideration share based payment expense relating to the Paragem acquisition.

4. OPERATING SEGMENT INFORMATION

Identification of reportable segments

The consolidated entity is organised into two operating segments: platform and licensee.

These operating segments are based on the internal reports that are reviewed and used by the executive management team (identified as the Chief Operating Decision Makers hereafter CODM) in assessing performance and in determining the allocation of resources.

The CODM reviews segment profits (Segment EBITDA) on a monthly basis.

The accounting policies adopted for internal reporting to the CODM are consistent with those adopted in the financial statements.

The principal products and services for each of the operating segments are as follows:

Platform

Development and provision of investment and superannuation platform services to financial advisers, stockbrokers, accountants and their clients.

Licensee

Provision of financial advice to clients through financial advisers authorised by Paragem Pty Ltd. The Licensee provides compliance, systems and support to adviser practices enabling advisers to provide clients with financial advice over a range of products.

The provision of corporate services supports these two operating segments and includes an allocation of executive headcount costs.

Fully paid ordinary shares carry one vote per share and carry the right to dividends.

On 15 September 2015, the company transferred 32,050 shares to eligible employees under the HUB24 Employee Share Ownership Plan.

6. FAIR VALUE MEASUREMENT

Due to their short term nature, the carrying amounts of cash and cash equivalents, current trade and other receivables and current trade and other payables is assumed to approximate their fair value.

7. PRIOR PERIOD ADJUSTMENTS AND RESTATEMENT OF COMPARATIVES

The research and development grant claimed from the Australian government (\$414,137) as a refundable tax offset for the year ended 30 June 2014, was classified as an income tax benefit in accordance with AASB 112 - Income Taxes.

During 2015 management changed its accounting policy and determined that the refundable tax offset meets the criteria of a government grant under AASB120 - Accounting for Government Grants and Disclosure of Government Assistance.

The company believes the change in accounting policy provides a better matching of costs and benefits associated with the research and development grant by deferring income and recognising the grant over the useful life of the asset. The impact of this change for the half year ended 31 December 2014 is an income restatement of \$109,748.
